1. Mandate of NIFTEM:

The Institute has been granted Deemed to be University status under De-novo category under Section 3 of the UGC Act, 1956.

The description of works is as below.

2. Scope of Work:

SECTION-A (BUS)

The Bidder is required to provide commercial vehicles fully conforming to RTO/RTA regulation along with fuel, driver, toll taxes, parking, other taxes etc and carryout periodical maintenance and execute the work through their Supervisor. They have to provide Buses/RTV vehicle to for NIFTEM for different training programmes at Kundli for pick and drop basis for office Use:

- Pick and drop to NIFTEM from designated points within Campus and radius of 200 Km and the above KMs if required by the institute.
- The night charges of the vehicle will also be quoted by the agency after 11:00 pm and before 6 AM including driver allowance.
- As specific running kilometers cannot be anticipated by the Institute. In the Financial Bid of the tender, bidder can submit their quote(s) for type of transport in different slab(s).
- At Railway stations/Airports the service of Placard to be made by the transport agency.
- To get log sheet approved on daily basis through the in-charge/transport officer.
- The following vehicle will be required by the institute:

- The additional mileage (excluding usage of PAX) for vehicle from garage to the campus (and return) will not given and from garage to New Delhi area (and return) would be 10 Kms. No millage will be allowed to the driver for lunch/breakfast/dinner, fuel filling etc.
- Sub-contracting will not be allowed at any cost.

SECTION-B (SEDAN/HATCHBACK/MUV/ MUV (LIGHT) ETC.)

The Bidder is required to provide commercial vehicles fully conforming to RTO/RTA regulation along with fuel, driver, toll taxes, octroi, other taxes etc and carryout periodical maintenance and execute the work through their Supervisor. They have to provide above mentioned vehicle(s) to NIFTEM for different programmes at Kundli for pick and drop basis for office Use:

- Pick and drop to NIFTEM from designated points within Campus and radius of 250 Km and the above KMs if required by the institute.
- The night charges of the vehicle will also be quoted by the agency after 11:00 pm and before 5 AM including driver allowance.

- C. As specific running kilometers cannot be anticipated by the Institute. In the Financial Bid of the tender, bidder can submit their quote(s) for type of transport in different slab(s).
- D. At the time of VVIP and VIP visits or pick up & drop the proper protocol will be managed by the transport agency.
- E. At Railway stations/Airports the service of Placard to be made by the transport agency.
- F. To get log sheet approved on daily basis through the in-charge/transport officer.
- G. The driver(s) will report at the time of the vehicle deployment to the user and transport in charge of the agency's supervisor and the supervisor shall inform the deployment to the vehicle to NIFTEM accordingly.
- H. The agency may be required to provide the driver on 8 hours, per additional hours, night stay charges if required.

- J. The additional mileage (excluding usage of PAX) for vehicle from garage to the campus (and return) will not given and from garage to New Delhi area, (and return) would be 10 Kms. No millage will be allowed to the driver for lunch/breakfast/dinner, fuel filling etc.

Contract Period: Initially for two years from the date of letter of Award. The period of contract can be extended further upto one year depending upon satisfactory performance & mutual consent on same terms & conditions.

3. Eligibility Criteria

The tenderers must fulfill the following eligibility criteria:-

- i. The Service Provider/bidder should have at least 03 years experience in providing transport services (LMV/LMV Light) in the Central Govt./ State Govt./ PSU/ University/ Research Institute/ Colleges/ MNC/ Private, etc. **Copies of work orders for last three financial years (2019-20, 2020-21 & 2021-22) alongwith copies of Completion Certificates/ Performance Certificate must also be attached in which one work order must be in Govt. Sector. The Completion Certificate for last three financial years should contain Date of start, Date of completion, Value on completion etc.**
- ii. The Annual financial turnover of the bidder during the last 03 Financial Years (2019-20, 2020-21 & 2021-22) ended 31st March, 2022 should be at least Rs. 50.00 Lakh (Attach audited copies of Balance Sheet, P&L Account Statement, ITR). The Certificate by CA regarding turnover must be attached.

- iii. The bidder has to submit an certificate that the vehicles which are provided by them are for commercial uses only.
- iv. The agency must have a fleet of 30 vehicles of various types (copy of RCs must be attached).
- v. The agency must have own drivers (at least 10) on pay roll (copy must be attached).
- vi. The drivers should have valid driving license, the agency to provide copies of driver's driving license (copy must be attached).
- vii. No subletting of work will be allowed at any stage.
- viii. The Hard Copy of original instruments in respect of cost of tender document, earnest money must be reached at this addressed to the "Registrar, National Institute of Food Technology Entrepreneurship and Management, Plot No.-97, Sector-56, HSIIDC Industrial Estate, Kundli-131028, District-Sonepat (Haryana)" on or before bid opening date and time as mentioned in critical date sheet.

Caution: All the bidders are specifically informed that while submitting tender, must ensure that signed documents as indicated in the tender documents are mandatory, otherwise tender will be similarly rejected and no second opportunity will be given to submit shortfall documents. In case of less bids, Institute has liberty to invite shortfall documents.

The agencies (registered with MSME /NSIC registration) willing to claim any relaxation/exemption in tender fee, Turnover and Experience, etc, must submit claim for the same alongwith support document for consideration, otherwise, the same will not be extended. The relaxation/exemption will only be given, if you are registered for **applied category** of item(s)/services, etc. Upload proper Udyog Adhar Certificate from both sides with specified validity and relevant service category. The bidders who are claiming relaxation/exemption are required to submit undertaking as per **Annexure-IV**.

4. Bidding Procedure

Bids shall be submitted online only at CPPP website: <https://eprocure.gov.in/eprocure/app>.

Tenderer/Contractor is advised to follow the instructions "Instructions To Bidder for Online Bid Submission".

Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.

Bidding Application must be accompanied by the following:-

The following documents are to be furnished by the Contractor along with Technical Bid as per the tender document (Scan Copies):

Opening of tenders (Technical bids only) will take place as mentioned in critical date sheet online at <https://eprocure.gov.in/eprocure/app> in the **"Meeting Hall, National Institute of Food Technology Entrepreneurship and Management, Plot No.-97, Sector-56, HSIIDC Industrial Estate, Kundli-131008, District-Sonepat (Haryana)"** in the presence of the representatives of the Firms/Tenderers, who may wish to be present at that time. At the time of tender opening Firms/Tenderers have to come with bid acknowledgement slip, that is generated by the system after successfully bid submission. Firms/Tenderers can view their live bid opening at their remote end also. No separate intimation will be sent to the firms/Tenderers in this regard

The tender not submitted in the prescribed formats or incomplete in detail is liable for rejection. NIFTEM is not responsible for non-receipt of tender within the specified date and time due to any reasons, including postal holidays or delays.

5. Evaluation Procedure

The eligibility of bidders and their technical bid will be evaluated by the Technical Evaluation Committee on the basis of documents submitted by the bidders with the Technical Bid. The financial bids will only be considered of those bidders who qualify the eligibility criteria and other terms and conditions laid down in the tender. In this regard the decision of Institute shall be final. The Award of Work will be made to overall L-1 Agency.

6. Service Points & Timings

The contractor shall be required to provide Buses/taxies/cars/vehicle on hire basis as and when required. The agency will be required to provide the services at a notice which in normal circumstances will be a minimum period of 2 hrs. However, in emergencies, vehicles may be required at shorter notice i.e. one hour.

General Term & Conditions

- i. **In case, after Pre-bid meeting (wherever applicable) any modification(s)/addition(s)/deletion(s) or any alternation in the requirement(s)/ specification(s) etc is required, the same will be appended on the NIFTEM website- www.niftem.ac.in, therefore, all the bidders are advised to visit our website before filling/submitted their tenders. No separate advertisement/information will be published in this regard in the Newspapers.**
- ii. Acceptance of tender will be intimated to the successful tenderer through a letter of intent (LOI) duly signed by the authorized signatory of the institution.
- iii. Performance Security of successful bidder may be forfeited, if the bidder withdraws or amends or derogates from the tender in any respect.
- iv. **Validity of bids should be 180 days from the date of closing of tender.**
- v. NIFTEM will not compromise with the quality/sub-standard material. At any stage, it is found that supplier has supplied inferior quality or different Payment shall be made for such items after reasonable deduction(s)/ rejection of the lot and forfeiting of Performance Security, as deemed fit, in the circumstances & decided by Institute.
- vi. **The EMD of ₹ 50,000/-** will be kept as Performance Security and will be refunded/ returned to the agency after satisfactory performance, without any interest after the expiry of contract period. The performance security should also remain valid for a period of sixty days beyond the date of completion of all contract obligation of the supply including guarantee obligation.
- vii. In any case, if tenders are not opened due to any reason, the Tender documents, processing Fee and EMD shall be returned to all bidders.
- viii. **Conditional Tender will not be accepted.**
- ix. The EMD of the unsuccessful bidder will be returned to them after completion of Technical Evaluation.
- x. Tender without EMD & Tender Fee will be summarily rejected.
- xi. The Institute can ask any clarifications & documents at any stage of the procurement depending upon the circumstances to ascertain quality of material used in manufacturing of items.
- xii. All the documents attached with the technical bid should be properly tagged, numbered, signed and stamped by the competent authority.
- xiii. The EMD/performance security shall be forfeited in case:-
 1. If the Bidder withdraws or amends, impairs or derogates from the tender in any respect within the period of validity of this tender.
 2. If the bidder having been notified of the acceptance of his tender by the Buyer during the period of its validity,

3. If the Bidder fails to furnish the Performance Security for the due performance of the contract.
 4. If the Bidder fails to sign the agreement.
 5. Fails or refuse to execute the contract.
 6. Fails to respond to queries by the NIFTEM.
- xiv. **The successful Bidder has to enter into an agreement with NIFTEM incorporating all clauses of the Tender document and any other as may be agreed to by both the parties on a Non-Judicial Stamp Paper of Rs.200/-.**

THE FOLLOWING TERMS AND CONDITIONS WILL APPLY IN CASE YOU ARE AWARDED THE WORK

- i. All the vehicle(s) should be neat and clear on all respect.
- ii. All the vehicle(s) should be insured and should have valid license to run the vehicle should be passed by the RTO.
- iii. The vehicle should be passed by the pollution authority and time to time it should be renewed.
- iv. NIFTEM will not be responsible for any kind of damages, losses, theft, claims, financial or other, fine/ Challan on account of violation of traffic rules, damage or accident to the vehicle or to any other vehicle or injury/loss to any driver and contracting agency will settle such issues on their own at their cost. Damage/ Loss to the NIFTEM staff will be recovered from the contracting agency/ firm/ company.
- v. The contract is not transferable. No sub-letting of the contract is permissible.
- vi. The contractor agency/firm/company shall provide immediate replacement for the breakdown vehicle with same/higher level of vehicle without additional cost to NIFTEM.
- vii. The contracting agency/firm/company shall deploy drivers on NIFTEM site only after police verification.
- viii. NIFTEM shall pay for the services under the contract at the rates mentioned in the Price Bid (Annexure-II) which shall be inclusive of fuel/lubrication/repair & maintenance of vehicle, wages of the driver, overtime, uniform, State Transport Taxes/permits fees, Insurance of the vehicle etc. Further, Service Tax will be paid extra. However, parking charges and toll tax, if any, paid by the agency will be reimbursed on the production of valid receipts along with monthly bills.
- ix. Agency/firm must ensure the compliance of various applicable laws, rules and regulations with respect to the manpower engaged by them for the purpose of smooth and efficient rendering of services to NIFTEM.
- x. In order to avoid mishap/accident, Agency shall ensure that only skilled drivers with sufficient experience in trade are deployed on vehicle and they observe all rules/precautions in this regard. The Agency shall ensure that driver do not exceed normal safe speed limits.

7. Payment Terms

The payment will be made on submission of monthly bill along with duly verified log sheet by the Officer I/c (Transport).

9. NIFTEM reserves the right to accept or reject any/all tenders without assigning any reason(s).
10. Tenders not on the prescribed Performa (attached), without requisite details, EMD and Processing Fee and received after the closing date/ time of tenders and tenders with any rider will summarily be rejected.
11. Canvassing in any form will be viewed seriously and if any tenderer is found to be resorting to such practices, the tender of such firm will be rejected.
12. **Arbitration Clause:** That in case of any dispute between party of first part(NIFTEM) and the part of other party(Agency) arising out of or in relation to the agreement, the dispute shall be referred to Hon'ble Director for arbitration. The award of the said Arbitrator shall be binding upon both parties. The seat of the arbitration shall be at NIFTEM, Kundli, Sonapat.
13. **Withholding of Payment:** This clause authorizes Buyer to withhold payment till end when seller fails in its contractual obligation. The standard text of this clause is as under:

"In the event of the Seller"s failure to submit the Bonds, Guarantees and Documents, supply the deliverables etc as specified in the Contract, the Buyer may at his discretion, withhold any payment

until the completion of the Contract”.

14. Right of Acceptance of Offer.

- (a) Buyer reserves the right to accept partly or reject any offer without assigning any reason thereof. The Buyer does not pledge itself to accept the lowest or any other tender and reserves to itself the right of acceptance of the whole or any part of the tender or portion of the quantity offered and the Seller shall supply the same at the rate quoted.
- (b) In respect of enquiries, which call for procurement of more than one item, the Buyer reserves the right to consider and accept the offer for any of the items in the enquiry reserving the right to utilize the offer for balance items at a later stage within the validity of offer.

15. Force Majeure

Should any force majeure circumstances arise, each of the contracting party shall be excused for the non-fulfilment or for the delayed fulfilment of any of its contractual obligations, if the affected party within 14 days of its occurrence informs in a written form the other party. Force majeure shall mean fires, floods, natural disasters or other acts such as war, turmoil, strikes, sabotage, explosions, and quarantine restriction beyond the control of either party.

16. Penalty for Use of Undue Influence

The Seller undertakes that he has not given, offered or promised to give, directly or indirectly any gift, consideration, reward, commission, fees brokerage or inducement to any person in service of the Buyer or otherwise in procuring the Contracts or forbearing to do or for having done or for borne to do any act in relation to the obtaining or execution of the Contract or any other Contract with the Government for showing or forbearing to show favour or disfavour to any person in relation to the Contract or any other Contract with the Government. Any breach of the aforesaid undertaking by the seller or any one employed by him or acting on his behalf (whether with or without the knowledge of the seller) or the commission of any offences by the seller or anyone employed by him or acting on his behalf, as defined in Chapter IX of the Indian Penal Code, 1860 or the Prevention of Corruption Act, 1988 or any other Act enacted for the prevention of corruption shall entitle the Buyer to cancel the contract and all or any other contracts with the seller and recover from the seller the amount of any loss arising from such cancellation. A decision of the buyer or his nominee to the effect that a breach of the undertaking had been committed shall be final and binding on the Seller.

Giving or offering of any gift, bribe or inducement or any attempt at any such act on behalf of the seller towards any officer/employee of the buyer or to any other person in a position to influence any officer/employee of the Buyer for showing any favour in relation to this or any other contract, shall render the Seller to such liability/ penalty as the Buyer may deem proper, including but not limited to termination of the contract, imposition of penal damages, forfeiture of the Bank Guarantee and refund of the amounts paid by the Buyer.

17. Right to Variation Clause

To take care of any change in the requirement during the period between issue of RFP and conclusion of contract, Buyer reserves the right to increase or decrease the quantity of the required deliverables by 50% without any change in the terms & conditions and prices quoted by the Seller. While concluding the contract, the quantity can be accordingly increased or decreased at the same terms of conditions.

18. Liquidated Damages (LD)

In the event of the seller's failure to submit the Bonds/Guarantees/ Documents or/and supply/performance the items/services as per Delivery schedule specified in the contract, the Buyer may, at his discretion, withhold any payment until the completion of the contract. The buyer may also deduct LD to the sum of 0.5% of the contract price of the delayed/undelivered stores/ services mentioned above for every week of delay or part of a week, subject to the maximum value of the Liquidated Damages being not higher than 10% of the value of delayed stores/services.

19. Cancellation of the Contract

NIFTEM shall have the right to terminate the Contract, arising out of finalization of this tender, in part or in full in any of the following cases :-

- a. The start of works is delayed for causes not attributable to Force Majeure for more than 10 days after the scheduled date of delivery.
- b. When both parties mutually agree to terminate the contract.

20. Modification and Withdrawal of Bids

Bidder can modify his bid any number of times before bid submission closing date and time. Bidder can also withdraw his bid before bid submission closing date and time. Withdrawn is allowed only once in a tender. If a bidder withdraws his bid, he cannot participate in the particular tender again.

Instructions for Online Bid Submission:

The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

- 1) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: <https://eprocure.gov.in/eprocure/app>) by clicking on the link “**Online bidder Enrollment**” on the CPP Portal which is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 6) Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

SEARCHING FOR TENDER DOCUMENTS

- 1) There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.
- 2) Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective 'My

Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS / e-mail in case there is any corrigendum issued to the tender document.

- 3) The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

PREPARATION OF BIDS

- 1) Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 2) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents - including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 3) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- 4) To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" or "Other Important Documents" area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

SUBMISSION OF BIDS

- 1) Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 2) The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- 3) Bidder has to select the payment option as "offline" to pay the tender fee / EMD as applicable and enter details of the instrument.
- 4) Bidder should prepare the EMD as per the instructions specified in the tender document. The original should be posted/couriered/given in person to the concerned official, latest by the last date of bid submission or as specified in the tender documents. The details of the DD/any other accepted instrument, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise the uploaded bid will be rejected.
- 5) Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BoQ file, open it and complete the white coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). - 8) Upon the successful and timely submission of bids (ie after Clicking “Freeze Bid Submission” in the portal), the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
- 9) The bid summary has to be printed and kept as an acknowledgement of the submission of the bid. This acknowledgement may be used as an entry pass for any bid opening meetings.
