- 2. The quotations received in time will be opened in NIFTEM, Plot No 97, Sec 56, Kundli, Sonipat. The bidders or their representative (not more than one) may remain present, if they so desire, at the time of opening of quotations.
- 3. The auction will be governed by the following conditions:
