Whereas the Central Government is empowered under Section 3 of the University Grants Commission (UGC) Act, 1956 to declare, on the advice of the UGC, an institution of higher learning as a deemed-to-be-university.

2 And whereas, a proposal was received for grant of status of deemed-to-be-university (under *de novo* category) to National Institute of Food Technology, Entrepreneurship & Management (NIFTEM), Kundli, Haryana, under Section 3 of the UGC Act, 1956,

3. And whereas, the University Grants Commission have examined the said proposal and vide their communication F.No.22-1/2010(CPP-I) dated the 30<sup>th</sup> April, 2012 have recommended conferment of status of 'deemed-to-be-university' under *de novo* category to National Institute of Food Technology, Entrepreneurship & Management (NIFTEM), Kundli, Haryana, under Section 3 of the UGC Act, 1956.

4. Therefore, in exercise of the powers conferred by Section 3 of the University Grants Commission Act, 1956, the Central Government, on the advice of the University Grants Commission (UGC), hereby declare that 'National Institute of Food Technology, Entrepreneurship & Management (NIFTEM), Kundli, Haryana, shall be deemed to be a university for the purposes of the aforesaid Act subject to usual conditions, annual review for 5 years by the UGC with the help of the Expert Committee. The NIFTEM shall obtain accreditation in respect of all its academic programmes from the National Board of Accreditation (NBA) / National Assessment and Accreditation Council (NAAC) (as may be relevant) within a period of six months. NIFTEM shall not also undertake franchising of higher education which is not permissible under any circumstances. NIFTEM is also not permitted to affiliate any college(s) / institution(s).

5. The declaration made in para 4 above is further subject to fulfillment/compliance of conditions mentioned at Sr. No 4 of the endorsement to this Notification.

  - (ii) The NIFTEM shall not offer any distance education programmes.
  - (iii) The NIFTEM shall not also open or operate any off campus or off shore campus centres without obtaining the prior approval of the UGC and the Government of India.
  - (iv) The academic programmes offered or to be offered by NIFTEM will conform to the norms and standards prescribed by the relevant Statutory Councils;
  - (v) The NIFTEM shall not offer / award, as the case may be, any degrees that are not specified by the UGC. It shall also ensure that the nomenclatures of the degrees, etc. to be awarded by it are specified by the UGC under Section 22 of the UGC Act, 1956.
  - (vi) All the prescribed norms and procedures of the relevant Statutory Councils and other authorities concerned in the matter of admission of students, intake capacity of students, starting of new courses / programmes, renewal of approval to the courses, etc. will continue to be in force, and shall be adhered to by the NIFTEM.
  - (vii) The NIFTEM shall take all necessary steps to comply with the observations and suggestions, if any, of the Expert Committee of the UGC as made out in its relevant Inspection Report;

NOTIFICATION

Whereas, the Central Government is empowered under Section 3 of the University Grants Commission (UGC) Act, 1956 to declare, on the advice of the UGC, an Institution of higher learning as deemed to be University.

2. And whereas, in exercise of the powers conferred by Section 3 of the UGC Act, 1956, the Central Government vide its Notification. No.9-28/2009-U3(A) dated 08.05.2012, declared National Institute of Food Technology, Entrepreneurship & Management (NIFTEM), Kundli, Sonapat, Haryana as an Institution deemed to be University under de-novo category, subject to annual review for 5 years by UGC with the help of Expert Committee.

3. And whereas, the functioning of NIFTEM, Kundli, Sonapat, Haryana was reviewed by the UGC with the help of its Expert Committee during 12-13<sup>th</sup> July, 2018. The report of the Expert Committee was placed before the Commission in its 534<sup>th</sup> meeting (Item No.2.07) held on 02.08.2018. The Commission passed the following resolution:

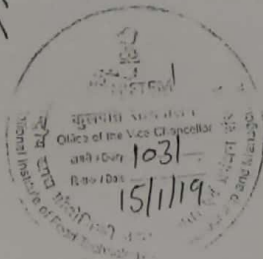
*"The Commission considered the report of the UGC Expert Committee and resolved to recommend to MHRD for Deemed to be University status to National Institute of Food Technology, Entrepreneurship & Management (NIFTEM), Kundli, Sonapat, Haryana for 2 years till 2020. The Institution Deemed to be University may be asked to get NAAC accreditation within two years and submit compliance report to UGC during this period."*

4. Now, therefore, in exercise of the powers conferred under Section 3 of the UGC Act, 1956, the Central Government, on the advice of the UGC, do hereby extend the deemed to be University status to National Institute of Food Technology, Entrepreneurship & Management (NIFTEM), Kundli, Sonapat, Haryana from 08.05.2017 to 30.06.2020 with the following conditions:

- a) The deemed to be University shall immediately approach National Assessment and Accreditation Council (NAAC) for accreditation.
- b) The deemed to be University shall submit a compliance report w.r.t. suggestions/deficiencies pointed out by the UGC Expert Committee.


5. All the other conditions mentioned in the earlier Notification(s) of this Ministry as well as the Rules / Regulations of UGC and other Statutory Councils, issued from time



2. और जबकि, केन्द्र सरकार ने यूजीसी अधिनियम, 1956 की धारा 3 द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए यूजीसी की सलाह पर अपनी दिनांक 08.05.2012 की अधिसूचना सं. 9-28/2009-यू3(ए) के तहत राष्ट्रीय खाद्य प्रौद्योगिकी, प्रशिक्षुता एवं प्रबंध संस्थान, (एनआईएफटीईएम) कुंडली, सोनीपत, हरियाणा को, विशेषज्ञ समिति की सहायता से यूजीसी द्वारा पांच वर्ष की वार्षिक समीक्षा के अध्यक्षीन, डी-नोवो श्रेणी के अंतर्गत सम-विश्वविद्यालय संस्था के रूप में घोषित किया था।

3. और जबकि, यूजीसी ने अपनी विशेषज्ञ समिति की सहायता से 12 से 13 जुलाई, 2018 के दौरान एनआईएफटीईएम, कुंडली, सोनीपत, हरियाणा की कार्यपद्धति की समीक्षा की थी। विशेषज्ञ समिति की रिपोर्ट को आयोग की दिनांक 02.08.2018 को आयोजित 524वीं बैठक (मद सं.2.07) में प्रस्तुत किया गया था जिसमें आयोग ने निम्नलिखित संकल्प पारित किया था :


"यूजीसी विशेषज्ञ समिति की सिफारिशों पर विचार करने के बाद आयोग ने राष्ट्रीय खाद्य प्रौद्योगिकी, प्रशिक्षुता एवं प्रबंध संस्थान (एनआईएफटीईएम), कुंडली, सोनीपत, हरियाणा को दो वर्षों, 2020 तक समवत विश्वविद्यालय का दर्जा प्रदान किए जाने हेतु एमएचआरडी से सिफारिश करने का संकल्प लिया था। समवत विश्वविद्यालय संस्थान से दो वर्ष के भीतर एनएएसी प्रत्यायन प्राप्त करने और इस अवधि के दौरान अनुपालना रिपोर्ट यूजीसी को प्रस्तुत करने को कहा जा सकेगा"

4. अब, इसलिए, केन्द्र सरकार एतद द्वारा यूजीसी अधिनियम, 1956 की धारा 3 के तहत प्रदत्त शक्तियों को प्रयोग करते हुए, यूजीसी की सलाह पर एतद द्वारा राष्ट्रीय खाद्य प्रौद्योगिकी, प्रशिक्षुता एवं प्रबंध संस्थान, (एनआईएफटीईएम) कुंडली, सोनीपत, हरियाणा को दिनांक 08.05.2017 से 30.06.2020 तक निम्नलिखित शर्तों के अध्यक्षीन समवत विश्वविद्यालय का दर्जा प्रदान करती है :

क) समवत विश्वविद्यालय प्रत्यायन हेतु राष्ट्रीय मूल्यांकन और प्रत्यायन परिषद (एनएएसी) से तत्काल सम्पर्क करेगा।

ख) समवत विश्वविद्यालय यूजीसी विश्वविद्यालय समिति द्वारा दिए गए सुझावों/विसंगतियों के संदर्भ में अनुपालना रिपोर्ट प्रस्तुत करेगा।

The Society/Trust/Institution shall obtain necessary affiliation / permission from the concerned affiliating University as per the prescribed schedule of the University/ Admission authority etc. The Applicant Society/Trust/Institution shall send information about commencement of the above courses to AICTE. In case the Institution is not in a position to commence the above mentioned courses for whatever reason during the two years period from the date of issue of this letter, the approval becomes invalid and the applicant Society/Trust/Institution shall make fresh application to AICTE for grant of approval as per the norms prevailing at that time.

All Institutions shall fulfill the following general conditions:

1. The management shall provide adequate funds for development of land and for providing related infrastructural, instructional and other facilities as per norms and standards laid down by the Council from time to time and for meeting recurring expenditure.
2. The admission shall be made only after adequate infrastructure and all other facilities, including the availability / recruitment of the required faculty are provided as per norms and guidelines of the AICTE.
3. The admissions shall be made in accordance with the regulations notified by the Council from time to time.
4. The curriculum of the course, the procedure for evaluation / assessment of students shall be in accordance with the norms prescribed by the AICTE and concerned affiliating university wherever applicable.
5. The management of the Institution shall not close the Institution or the institution shall not discontinue any course(s) or start any new course(s) or alter intake capacity of seats without the prior approval of the Council.
6. No excess admission shall be made by the Institution over and above the approved intake under any circumstances. In case any excess admission is reported to the Council, appropriate action as per the notified regulations shall be initiated against the Institution.
7. The institutions shall not have any collaborative arrangements with any Indian and / or Foreign Universities for conduct of technical courses other than those approved by AICTE without obtaining prior approval from AICTE. In case any violation is reported to the Council, appropriate action as per the notified regulations shall be initiated against the Institution.
8. The Institution shall not conduct any course(s) in the field of technical education in the same premises / campus and / or in the name of the Institution without prior permission / approval of AICTE. If found so, appropriate action as per the notified regulations shall be initiated against the Institution.
9. The institution shall not conduct any non-technical course (s) in the same premises / campus under any circumstances. In case any violation is reported to the Council, appropriate action as per the notified regulations shall be initiated against the Institution.
10. The institution shall operate only from the approved location, and that the institution shall not open any off campus study centers / extension centers directly or in collaboration with any other institution / university / organization for the purpose of imparting technical education without obtaining prior approval from the AICTE. If found so, appropriate action as per the notified regulations shall be initiated against the Institution.

11. The tuition and other fees shall be charged as prescribed by the Competent Authority within the overall criteria prescribed by the Council from time to time. No capitation fee shall be charged from the students / guardians of students in any form. If found so, appropriate action as per the notified regulations shall be initiated against the Institution.
12. The accounts of the Institution shall be audited annually by a certified Chartered Accountant and shall be open for inspection by the Council or anybody or persons authorized by it.
13. The Director / Principal and the teaching and other staff shall be appointed in given time frame and selection shall be done according to procedures, qualifications and experience prescribed by the Council from time to time and pay scales are as per the norms prescribed by the Council from time to time.
14. The technical institution shall publish an information booklet before commencement of the academic year giving details regarding the institution and courses / programs being conducted and details of infrastructural facilities including faculty etc. in the form of mandatory disclosure. The information booklet may be made available to the stakeholders of the technical education. The mandatory disclosure information, as per directions in the AICTE website / Approval Process Handbook, shall be put on the Institution Website. The information shall be revised every year with updated information about all aspects of the institution.
15. It shall be mandatory for the technical institution to maintain a Website providing the prescribed information. The Website information must be continuously updated as and when changes take place.
16. If a technical Institution fails to disclose the information or suppress and / or misrepresent the information, appropriate action as per the notified regulations shall be initiated against the Institution.
17. AICTE may carry out random inspections round the year for verifying the status of the Institutions to ensure maintenance of norms and standards.
18. AICTE may also conduct inspections with or without notifying the dates to verify specific complaints, to verify adherence to AICTE norms & standards, and to verify any mis-representation, violation of norms & standards, mal-practices etc.
19. The Institution by virtue of the approval given by Council shall not automatically become claimant to any grant-in-aid from the Central or State Government.
20. In the event of a student / candidate withdrawing before the starting of the course, the wait listed candidates should be given admission against the vacant seat. The entire fee collected from the student, after a deduction of the processing fee of not more than Rs. 1000/- (Rupees one thousand only) shall be refunded and returned by the Institution / University to the student / candidate withdrawing from the program. It would not be permissible for Institutions and Universities to retain the School / Institution Leaving Certificates in original to force retention of admitted students.
21. The Institute shall take appropriate measures for prevention of ragging in any form, in the light of AICTE regulation "Prevention and Prohibition of Ragging in Technical Institutions, Universities including Deemed to Universities imparting technical education" Regulation 2009 (F.No. 37-3/Legal/AICTE/2009 dated 01/07/2009). In case of failure to prevent the instances of ragging by the Institutions, the Council shall take
