

Dr. Vinay Kumar filed an application dated 20.02.2020 regarding recruitment of Assistant Professor in AES Department vide advt. no. N/S/K/P&A/1595/2019. He sought information about screening criteria, marks obtained by each candidate, cut off marks, Academic specialization of AES department and details about composition of screening committee. A reply was sent to him vide letter dated 22.05.2020 which is reproduced below:

for Award of M.Phil/Ph.D Degree) Regulations, 2009 or 2016 and their amendments from time to tome as the case may be exempted from NET/SLET/SET

Provided the candidates registered for the Ph.D programme prior to July 11, 2009 shall be governed by the provisions of the then existing Ordinances/Bye –laws/Regulations of the Institution awarding the degree and such Ph.D candidates shall be exempted from the requirement of NET/SLET/SET for requirement and appointment of Assistant Professor or equivalent position in the Universities/Colleges/Institutions subject to the fulfillment of the following conditions. The Ph.D degree of the candidate has been awarded in a regular mode:-

- a) The Ph.D thesis has been evaluated by at least two external examiners.
- b) An open Ph.D viva-voce of the candidate has been conducted.
- c) The candidate has published two research papers from his/her Ph.D work, out of which at least one is in a refereed journal.
- d) The candidate has presented at least two papers based on his/her Ph.D work in conferences/seminars/sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.

The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

Note:- NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET

# 6. Details about the composition of Screening Committee

Constitution of Selection Committee and Guidelines on Selection Procedure as per UGC Regulations, 2018 is as under:-

(Same for all posts) (Professor, Associate Professor, Assistant Professor)

- i) Vice Chancellor who shall be the Chairperson of the Committee
- Ii) An academician not below the rank of Professor to be nominated by the Visitor/Chancellor, wherever applicable.
- lii) Three experts in the subject/filed concerned to be nominated by the Vice Chancellor out of the panel of names approved by the relevant statutory body of the University concerned.
- Iv) Dean of the faculty, wherever applicable
- v) Head/Chairperson of the Department/School
- vi) An academician belonging to the SC/ST/OBC/Minority/Women/ Differently abled categories, if any of the candidates representing these categories is the applicant, to be nominated by the Vice Chancellor, if any of the above members of the selection committee does not belong to that category.
- vii) At least four members, including two outside subject experts, shall constitute the quorum.

Aggrieved upon above reply, Dr. Vinay Kumar has made a first appeal to the Appellate Authority. He has again requested the following information to be furnished:

- 1. Certified copy of screening criteria of the recruitment process- Information is already provided, however, copy of Table 3A of UGC regulations 2018 is attached at annexure -1 for reference.
- 2. Marks scored by each candidate applied for faculty position- Attached list of candidates applied for Assistant Professor position in AES department under UR category at annexure -2.
- 3. The cut off marks for each department- Attached as annexure 3
- 4. Marks obtained by selected candidate- Dr. Vinay has requested for marks allocated for interview and marks distribution which is attached as Annexure -4.
- 5. Academic specialization of AES Department- information already provided is sufficient and evidentiary explained.
- 6. Details about the composition of Screening Committee- Composition of screening committee is as under:
  - Academician at the level of Assistant Director General in National level organization.
  - Academician at the level of Professor in State University.
  - Academician at the level of Principal Scientist in National level organization.

Thus, Dr. Vinay Kumar has already been given all the necessary information relating to his candidature for the post of Assistant Professor in AES department. His appeal is disposed off accordingly


