## **Office Order**

In pursuance of the Government of Haryana, HSDMA Order No. DMC-SPO-2020/14198, dated 1.1.2022, regarding imposition of guidelines of Mahamari Alert- Surakshit Haryana, as an emergency measures for well-being and safety of people in the campus, all stakeholders of NIFTEM are hereby informed that the night curfew will be in force in the campus with immediate effect from 11.00 p.m. to 5.00 a.m. till further orders.

The following additional activities are allowed:

- 1. No faculty and staff members or students shall be allowed in campus without having vaccinated with both doses for COVID.
- 2. Persons coming from /going to attend regular duties and day-to-day activities in the campus are allowed on production of valid I-card and strict observance of COVID-19 appropriate behavioural norms and social distancing.
- 3. Persons who are engaged in emergency services, medical emergency and supply of goods, those engaged on contract for providing services in NIFTEM (Horticulture, housekeeping etc.), those visiting campus for providing services (self-employed persons) such as electricians, plumbers, repairing of water purifiers etc. are allowed on production of valid I-card and strict observance of COVID-19 appropriate behavioural norms and social distancing.
- 4. Persons coming from /going to emergent medical treatments are allowed subject to recommendation from the Medical Officer of NIFTEM.
- 5. Persons coming from /going to Airport/ Railway station/ISBTs are allowed to travel on production of valid ticket.
- 6. Essential goods and services for food, groceries, fruits & vegetables, dairy & milk, educational books for students and electric fans, distribution of News papers, ATMs of banks, Telecommunications, Internet services, Cable services, IT and IT enabled services, Bank and Postal services and any services designated as essential services by HSDMA are allowed without restriction.
- 7. Delivery of all type of goods through e-commerce are allowed on production of valid Icard issued by the employer / firm/ company.
- 8. The other essential/emergency services shall function to the extent of 100% strength.

- 9. The NKC will remain open only upto 10.00 p.m. The users are allowed subject to strict observance of COVID-19 appropriate behavioural norms and social distancing.
- 10. Gathering of more than 4 persons at one place should be avoided in the campus to minimise the spread of COVID-19 virus.
- 11. All authorised shops and canteens, Barber shop/Saloon/Beauty parlour are allowed to open till 10.00 p.m. The owner of the shops / canteens are further instructed to ensure strict adherence to the prescribed SOP and all instruction/guidelines issued by Government of India / Government of Haryana / NIFTEM orders from time to time as well as compliance of COVID appropriate behaviour viz. wearing of masks, maintaining social distancing, regular hand washing and use of sanitizer etc. to contain the spread of COVID-19 virus.
- 12. The shopkeepers are further instructed to maintain the all COVID Appropriate Behavior viz. wearing of masks, maintaining social distancing, regular hand washing and use of sanitizer, maintaining health hygiene, no spitting, no consumption of liquor, pan, gutkha, tobacco etc. at all the times. Any violation would attract closure of shops in view of public health hazard and further violation will be dealt strictly as per the order/guidelines of GOI/Haryana Government/NIFTEM.
- 13. The permitted/restricted activities shall be allowed subject to strict compliance of SoPs issued by GoI and HSDMA from time to time.
- All faculty and staff members and the Security Section of the NIFTEM shall ensure COVID Appropriate Behavior viz. wearing of face mask, maintaining of social distancing etc. in all areas as well as at all shops which are providing essential goods & services. It should be ensured that the people, who are visiting these shops, are strictly following COVID Appropriate Behavior and are wearing face masks, maintaining social distancing etc. without fail.
- The Security Section of NIFTEM shall ensure effective checking of movement of persons and vehicles in the campus by putting checking points with the objective to prevent unnecessary movement of people on roads. The Security Section shall also ensure that movement of individuals and vehicles should be allowed strictly as per guidelines/protocols prescribed in this order.
- The Security Section of NIFTEM, the faculty Incharges and the ARs concerned are instructed to ensure strict compliance of this order, and shall adequately inform and sensitize the field functionaries about these instructions for strict compliance, in letter and spirit within 2 days (with a copy to Administration). All entry gates of the campus shall be closed in the curfew timings.
- The labours from the construction sites will be allowed to visit shops only at particular timing (2-3 times in a day) so that they will not come into contact with other persons in

the campus. The DSW and Engineering Section have to bring out necessary guidelines in this regard.

- The Campus residents are hereby instructed not to move within the campus during the curfew timings.
- Employees and their family members, and students who are tested positive or under home isolation/quarantine, must inform with supporting documents immediately to the Administration / Medical Officer.
- The NIFTEM Dispensary should take all necessary measures to meet the contingency requirements related to COVID and also make necessary arrangements for the vaccination of all persons in the campus.
