- 5. Incomplete application form without photograph, signatures and other documents shall be summarily rejected. NIFTEM shall not entertain any correspondence in case of incomplete information and evidences.
- 6. No correspondence regarding consideration of late applications will be entertained.
- 7. The prescribed essential qualifications are the minimum and the mere possession of the same does not entitle candidates to be called for interview. Where the number of applications received in response to an advertisement is large and it will not be convenient or possible to interview to a reasonable limit on the basis of qualifications / experience higher than the minimum prescribed in the advertisement.
