EXPRESSION OF INTEREST (EOI)

SUBJECT: EOI FOR THIRD PARTY AUDIT OF FORTIFIED RICE KERNEL / PREMIX MANUFACTURERS.

1. About NIFTEM-K

NIFTEM-Kundli (Institute of National Importance) is a premier academic and research institution under the Ministry of Food Processing Industries (MoFPI), Government of India. It is dedicated to advancing food technology, entrepreneurship, and management. The institute's state-of-the-art facilities and innovative research focus on bridging gaps between academic knowledge and industry requirements to create solutions that address food safety, sustainability, and global competitiveness.

2. Background

Rice fortification, a process of adding micronutrients like iron, folic acid, and vitamin B12, is an effective, preventive, and cost-efficient complementary strategy to address the nutrition problem by making it more nutritious. Considering that rice is the staple food for approximately 65 percent of the Indian population, fortification has the potential to significantly impact public health, particularly among vulnerable and economically disadvantaged communities, including those benefiting from government safety net programs.

The Government of India has recognized the significance of fortified rice as a flagship program in combating malnutrition and improving public health. The Food and Civil Supplies Departments of various states empanel rice millers and Fortified Rice Kernel (FRK) Manufacturers to supply fortified rice to the Food Corporation of India (FCI) and states Godowns, which, in turn, distributes it to social safety net schemes.

There are growing concerns about the quality and safety of Premix & Fortified Rice Kernels (FRK) manufactured in the country, particularly in major CMR States (Punjab, Haryana, Uttar Pradesh & Chhattisgarh). The field visits and observations have revealed a notable lack of compliance with Good Manufacturing Practices (GMP) and Good Hygiene Practices (GHP)

among FRK & Premix manufacturers. Additionally, substandard raw materials in premixes result in substandard FRK that fails to meet the quality norms set by FSSAI.

To address these concerns and uphold the integrity of the Fortified Rice supply chain, NIFTEM proposes to conduct a Third-party Audit of Fortified Rice Kernel Manufacturers in abovementioned states, having significant number of FRK Manufacturers supplying substantial quantities of FRK across the country.

The objective of this audit is to thoroughly assess the compliance of FRK/ Premix manufacturers with FSSAI Schedule-IV requirements, Good Manufacturing Practices (GMP), Good Hygiene Practices (GHP), Micronutrient levels, and other relevant quality norms established by the FSSAI. By conducting this audit in partnership with FSSAI-approved agencies, NIFTEM aims to ensure transparency, credibility, and impartial evaluation of the manufacturers' operations.

The results of the third-party audit will provide valuable insights of FRK manufacturing, helping identify areas for improvement. Moreover, the audit will facilitate the implementation of a rating system based on the audit findings, encouraging manufacturers to continually enhance their practices.

Objective: The primary objective of the Third-party Food Safety Audit is to assess and evaluate the compliance of FRK/ Premix manufacturers with FSSAI Schedule-IV requirements, GMP, GHP, Micronutrient level, and other relevant quality norms. The audit aims to address concerns related to non-compliance and poor quality FRK/ Premix production while ensuring impartiality and transparency.

3. Eligibility

1. Identification of Potential Audit Agencies:

To ensure an unbiased and transparent audit process, the identification and shortlisting of the audit agencies will be carried out based on a comprehensive evaluation process. The following criteria will be used to assess potential agencies:

a. **Accreditation:** Preference will be given to agencies accredited by relevant national or international bodies for food safety auditing. The Agency shall be recognized as 3rd party audit agency by FSSAI. Weightage will be given to NABCB registered agencies.

b. **Expertise:** Agencies with a proven track record in conducting food safety audits, particularly in the field of fortified/extruded foods, will be considered. Experience of more than 5 Years as NABCB approved certification body for FSMS in the required category will be an added advantage.

c. **Technical Competence:** The technical expertise and qualifications of the auditors employed by the agencies will be evaluated. The certification body/auditing agency should have a minimum of 5 FSMS (ISO 22000:2018) approved auditors in the applicable category fortified/extruded foods with Geographical presence i.e. minimum 1 office in North, South, East & west of India.

d. **Past Performance:** The agencies' history of conducting similar audits and their performance in ensuring food safety compliance will be assessed.

4. Shortlisting Process:

A screening committee comprising representatives of NIFTEM will be formed to assess the proposal of audit agencies based on the above criteria. After a thorough evaluation, the agencies will be shortlisted and invited to participate in the audit process. NIFTEM-K may engage agencies as per the requirement.

- **5. Scope of Work:** The scope of the Third-party Food Safety Audit will encompass the following aspects:
 - 1. Evaluation of Infrastructure: Assessing the compliance of FRK / Premix manufacturers' infrastructure with FSSAI Schedule-IV requirements, including manufacturing facilities, storage, and handling practices.
 - 2. Verification of Nutrient Premixes: Verifying the use of standard quality nutrient premixes as per FSSAI guidelines and validating the authenticity/ traceability of raw material sources.
 - 3. Quality Control Measures: Assessing the overall quality control measures implemented by the manufacturers to produce fortified rice kernels / Premix.
 - 4. Compliance with GMP and GHP: Ensuring that the manufacturers adhere to Good Manufacturing Practices (GMP) and Good Hygiene Practices (GHP) to maintain food safety and hygiene standards using 3rd Party audit checklist from FSSAI for FRK and Premix manufacturing.
 - 5. Sampling: Sampling of FRK and Premix along with the relevant raw materials used in manufacturing process of FRK/Premix to be submitted to NIFTEM for analysis as per FSSAI requirement.
 - 6. Impartiality and Transparency: Ensuring that the audit process is conducted with complete impartiality and transparency, free from any undue influence from the manufacturers.

6. Deliverables:

- 1. Third-party Food Safety Audit: Conducting the audit of FRK Premix manufacturers in Punjab, Haryana, Uttar Pradesh and Chhattisgarh covering the specified scope of work and objectives.
- 2. Sampling of Finish Good FRK/Premix along with the relevant raw materials used in manufacturing process of FRK/Premix to be submitted to NIFTEM for analysis as per

FSSAI requirement. The auditors will be trained by NIFTEM team on sampling protocols during orientation program after empanelment.

- 3. Audit Report: Preparing a comprehensive audit report that includes findings, observations, identified non-compliances, and recommendations for improvement.
- 4. Rating System: Developing an impartial rating system to assess the performance of each FRK manufacturer based on the audit results.
- 5. Sharing Observations: Sharing all audit observations, ratings, and reports with NIFTEM/FSSAI to facilitate appropriate actions, policy improvements, and continual enhancement of food safety standards.
- 6. Continual Improvement: Promoting continual improvement among FRK manufacturers based on the audit ratings, aiming to enhance the overall quality of fortified rice available to beneficiaries.
- 7. Collaboration and Guidance: Providing support and collaboration throughout the audit process to ensure the success and effectiveness of the initiative.
