SCHOLARSHIPS FOR NIFTEM STUDENTS

NIFTEM invites applications from the eligible students for awarding the following scholarships -

- A. Merit Scholarship
- B. Merit cum Means Scholarship
- C. Corporate Scholarship

Eligible Students: Following Batch students can apply-

- a) B.Tech (2023-27)
- b) B.Tech (2022-26)
- c) B.Tech (2021-25)
- d) M. Tech (2024-2026)
- e) M.Tech (2023-2025)
- f) M.B.A. (2024-26)
- g) M.B.A (2023-25)

Rules and Regulations for these scholarships-

A) Merit Scholarship

The Scholarship is aimed to promote bright students excelling in the academics.

A.1 **No. of Scholarships:** Total no. of scholarships will be for the first 3 students on merit in each batch of B.Tech. and one student on merit in each programme and batch of M.Tech & M.B.A

A.2 **Amount of scholarships:** The scholarship will include proportionate tuition fee waiver based upon merit (100% waiver for first position, 90% waiver for second position and 80% waiver for third position holders) and a fixed annual stipend of Rs. 12000/-.

A.3 Criteria for scholarships:-

M. Tech. & M.B.A	First Year (Second semester onwards)	Result of First semester examination
	Second year	Result of I & II semester

B. Merit-cum-Means Scholarships

Institute Merit-Cum-Means scholarship will be awarded to B.Tech/M.Tech, and MBA students of the institute strictly on Merit-Cum-Means basis for needy students having limited family resources.

B.1 No. of scholarships: Total of 5 students of each batch will be considered for award of scholarship in B. Tech. and M. Tech. (one each in all the five streams). NIFTEM will extend 3 Merit-cum-Means scholarship to MBA students, to be admitted in 2024-25 and onwards, in line of existing policy of the Institute applicable to M.Tech students of the Institute.

B.2 Amount of scholarships: It includes 70% tuition fee waiver and a fixed annual stipend of Rs. 12000/-.

B.3 Eligibility Criteria

- i) The student should satisfy Merit Cum Means Criteria as adopted by institute and approved by Board of Management.
- ii) The annual gross income of parents of student from all sources should not exceed Rs. 500,000/-. (Income Certificate of FY 2024-2025 will only be considered duly issued from the Tehsildar/ Local District Administration. ITR statement will not be considered)



- iii) Students are not considered for scholarships if they have passed their +2 examination from schools with annual tuition fees of more than Rs. 50,000.00 per annum.
- iv) All papers must have been cleared with minimum B grade and above only.
- v) Students must have attained at least eighty five percent (85%) attendance.
- vi) Only one scholarship will be awarded to each student. (if any student has taken TWF or other fellowship, he/she is not eligible for this scholarship)

B.4 Calculation of merit cum means scores for ranking

The merit cum means scores for ranking will be calculated by giving weightage to parental income and merit of student as follows:

Weightage of parental income -40%

Weightage of merit of student -60%

Parents' Income weightage will be calculated as under:

Annual Income	Marks
Annual income below Rs.1 Lakh	100 marks
Rs. 1 Lakh - 1.5 Lakh	95
Rs. 1.5 Lakh - 2 Lakh	90
Rs. 2 Lakh - 2.5 Lakh	85
Rs. 2.5 Lakh-3 Lakh	80
Rs. 3 Lakh-3.5 Lakh	75
Rs. 3.5 Lakh-4 Lakh	70
Rs. 4 Lakh-4.5 Lakh	65
Rs. 4.5 Lakh-5 Lakh	60

The weightage of merit score will be considered based on SGPA of previous semesters.

C. Corporate Scholarships

C.1 Eligibility Criteria

1. Student must attain minimum B grade as over all in the evaluating semesters and above only and must have attained at least eighty five percent (85%) attendances.
2. The student should not have been penalised or must not have been awarded any major disciplinary punishment by the institute disciplinary committee.
3. The annual gross income of parents of student from all sources does not exceed Rs. 2,50,000/-. (Income Certificate of 2024-2025 will only be considered duly issued from the Tehsildar/ Local District Administration. ITR will not be considered)



4. Students will not be considered for scholarship if they have passed their +2 examination from schools with annual tuition fees of more than Rs. 30,000/- per annum.

5. The merit cum means scores for ranking will be calculated by giving weightage to parental income and merit of student as follows:

Weightage of parental income -50%

Weightage of merit of student -50%

Parental income weightage will be calculated as under:

Annual Income	Marks
Annual Income below Rs.1 Lakh	100
Rs.1 Lakh to 1.5 Lakh	95
Rs.1.5 Lakh to 2 Lakh	90
Rs.2 Lakh to 2.5 Lakh	85

The weightage of merit score will be considered based on average SGPA of previous two semesters.

Evaluation Formula for all the above mentioned scholarships:-

Ranking will be based on weightage (50%) of merit score + weightage (50%) of score of parent income.

All the students who wish to apply for the above scholarships are directed to submit a duly filled prescribed application form along with relevant documents to Office of DEAN(SW) latest by 10th March, 2025 by 1700 hrs. to dsw.niftem@gmail.com along with hard copy. No extension of Date will be permitted. Forms / Documents sent on other e-mails will not be entertained. Student must apply only in one scholarship scheme which he/she deems fit as per his/ her eligibility. Multiple forms / Incomplete forms submission may result in summarized rejection without assigning any reason.
