Ltd. has not submitted required work orders regarding organizing atleast 05 national/international events with the value of ₹ 35.00 Lakh or more but the average turnover of the bidder during last 05 years is more than Rs. 2.00 Crore, hence, TEC declared them qualified in pre-qualifying eligibility criteria.
