

## ABOUT THE INSTITUTE

National Institute of Food Technology Entrepreneurship and Management, Kundli (NIFTEM-K) was established as an institute of Excellence in the field of Food Science and Technology by the Ministry of Food Processing Industries (MoFPI), Government of India in 2012 as a Deemed to be University (De Novo Category) under Section 3 of UGC Act 1956 until September 2021. This is the only institute in the country with a University status exclusively in the area of Food Processing. The mandate of NIFTEM-K is to offer high quality education, research and management programmes specific to the food industry, disseminate knowledge to the food sector, provide referral advice on food standards and provide business incubation facilities.

The NIFTEM Act 2021 was published in the Gazette of India on 30 July 2021. The NIFTEM Act 2021 came into force through the notification of the Gazette of India on 1 October, 2021. The objectives of the legislation are, to confer the status of Institutions of National Importance (INI) to NIFTEM-K to provide for functional autonomy to the institutes to design and develop courses, undertake research activities and leverage enhanced status in their academic pursuits so that they become world class institutes, and to implement the reservation policy of the Government and also undertake special outreach activities for the benefit of concerned stakeholders.

**Location:** The institute is situated in the HSIIDC Industrial Estate, Kundli on Delhi-Haryana Border. Kundli belongs to Sonapat district of Haryana state. The nearest Metro Station is Jahangirpuri, which is 19 km from NIFTEM-K. The distance from Delhi Bus Stand (ISBT- Kashmiri Gate) and New Delhi Railway Station from NIFTEM-K is about 30 km and 35 km, respectively. Nearest Airport is Indira Gandhi International Airport, Delhi which is located at a distance of 55 km and the nearest Railway Station is Sonipat, which is 20 km from the institute.

## **DEPARTMENTS AT NIFTEM-K**

There are five academic departments in NIFTEM-K viz. Department of Food Science and Technology (FST), Department of Food Engineering (FE), Department of Food Business Management and Entrepreneurship Development (FBMED), Department of Interdisciplinary Sciences (IDS) and Department of Agriculture and Environmental Science (AES). ## **NIFTEM KNOWLEDGE CENTRE (NKC)**

NIFTEM-K Knowledge Centre has a unique set up of Information and Library Network system, and is equipped with modern infrastructure like ILM KOHA, 3M's RFID security system facility, information KIOSK, CD/DVD library with electronic CD/DVD holder, digital library and projector room. The resources include number of on-line full text databases, e- books, e-journals, standards besides collection of print materials in the form of books, journals, magazines, theses, reports etc. The NKC has also subscribed Knimbus mLibrary platform to provide remote access to all its subscribed e-contents for all registered members. It has reprography / printing / scanning facility, digital library with 12 multimedia PCs, Indexing / Barcode system and OPAC (Online Public Access Catalogue) with a seating capacity of more than 230 students.

## **RESIDENTIAL & AMENITIES**

The institute is a residential campus equipped with the basic amenities required for day to day needs like the shops, laundry, dispensary, canteen, gymnasium, stationery shop with photocopy facility and indoor & outdoor sports facilities. The Porta Cabins are also developed, for the visiting guests with the attached bath facilities and the sports complex. The Institute has sufficient hostel facilities for both boys & girls. The hostel rooms are available on a single, double & triple sharing basis.

## Central Government Scholarships

For National Scholarship Portal, it is to inform all the students that Institute Code is U-0989. Respective students may apply for the scholarship as per the eligibility using the code U-0989. Various schemes under different Ministries/Departments are available in the National Scholarship Portal for the students to receive the financial assistance.

## State Government Scholarships

The institute is already registered for various state government state scholarships like Rajasthan, Madhya Pradesh, Manipur, Andhra Pradesh etc.

## Institute Scholarships

Scholarships are important part of academic institution, whereby deserving students are supported to excel in their studies. NIFTEM-K has the policy of supporting students who not only excel in studies but also have limited resources to meet their regular needs. All the admitted M. Tech students with a valid GATE score receive the institute fellowship as per Ministry of Education (MoE) norms. In addition to the Central/ State govt. scholarships for SC/ST/ OBC etc., NIFTEM-K provides following Merit, Merit-cum-means and Industry Sponsored (Corporate) scholarships. The eligibility criteria is notified by the Dean (Student Welfare) once in a year.

## General Admission Information

**ATTENTION:** *Aspirants must read this section before referring to the programme of interest and filling up the online application form.*

1. Reservation for Indian Nationals: The number of seats in each of the programs at NIFTEM-K, as announced in these admission guidelines, shall be strictly adhered to, except for such minor adjustment as may be necessary on account of rounding off of fractions to accommodate reservations, as given below:
  - 27% reservation for Other Backward Class (from non-creamy layer and with a valid certificate

indicating eligibility for admission to central government institutions only. Please refer to brochure for Undertaking and format of certificate for claiming reservation under this category).

Only valid certificates will be considered at the time of counselling/admission.

- 15% for candidates belonging to the Scheduled Castes.
  - 7.5% for candidates belonging to the Scheduled Tribes.
  - 10% seats for Economically Weaker Sections, Further, 5% seats are reserved (horizontal reservation) for Persons with Disabilities (PWD) candidates.
2. The PWD candidates should have a minimum of 40% disability, provided that the claimant in this category is otherwise capable to pursue the course for which the admission is sought. All physically challenged persons should produce a certificate of their permanent physical disability from a CMO/Civil Surgeon of a District or Director/Principal or a Professor of a Medical College affiliated to University or an institution of national importance.
  3. Due reservation and concessions would be given to Kashmiri Migrants as per Government of India norms, provided they clearly mention their category in application forms as mentioned below:
    - Relaxation in cut off percentage up to 10% subject to minimum eligibility requirement.
    - Increase in super numerary quota upto 5% in each programme.
  4. Entrance test for M.Tech non-GATE, MBA & Ph.D. candidates will take place at NIFTEM-K Campus, Kundli, District Sonipat, only. There is no other centre within or outside the country. The candidates must visit website regularly for further details.
  5. Application forms for admission at NIFTEM-K are to be filled online only. Applicants should not send the printed copy of application form to NIFTEM-K. Admission brochure/guidelines are available on the website.
  6. Final merit list and counselling schedule will be uploaded on the institute website only. For such information/updates, the website should be visited frequently. It may be noted that no postal communication will be made to any applicant in this regard.
  7. However, in the interest of applicants, NIFTEM-K also attempts to send email alerts on the numbers and e-mail ID respectively provided in the application form by the candidate. Onus of any delivery failure in this regard would depend on the applicant. It is advised that DND facility and other restrictions, if opted on the mobiles, should be deactivated during the admission period. The entries of mail ID and mobile numbers in the application form must be made correctly with utmost care.
  8. Under unavoidable circumstances, any prescheduled event/activity given as admission timeline in the brochure may be changed. All such official notifications including merit notification and change in date, if any, will be made available on the NIFTEM-K website only.

## **Important Note**

Candidates who fail to produce valid category/ physically challenged certificate during the counseling will be considered under GENERAL category and will automatically lose their claim of due reservation.

1. The caste certificate should be in the name of the candidate seeking admission. The caste certificate in the name of either of parents (Father/Mother/Husband) is not acceptable. The name and other particulars in the caste certificate should be same as in application form as well as in the 10<sup>th</sup> and 12<sup>th</sup> class or equivalent certificates. Any variation in the name or other particulars in reserved category certificate may lead to refusal for admission by Admission Cell in the prescribed category.
2. In the absence of caste certificate, the candidate will not be entitled for any provisional admission in reserved category on the basis of any undertaking.

In the absence of mandatory documents of proof for eligibility, the candidates will not be allowed for admission to the programmes. The admission offered to a candidate who has been provisionally admitted to a program will stand cancelled if he/she does not submit the relevant documents in original pertaining to admission (such as Marks Sheet, Date of Birth Certificate etc.) in the Academic Cell before the stipulated date.

3. Admission to the programmes will be subject to verification of facts as in the original certificates/ documents provided by the candidates. In case any discrepancy is noticed, even at a later point of time after, NIFTEM-K reserves all rights to cancel the admission and such a decision shall be final and binding on the candidate(s).
4. It is the responsibility of the candidates to ascertain whether they possess requisite qualification for admission.
5. If the candidate(s) furnish the marks of the qualifying examination in CGPA/OGPA, the marks in percentage will be calculated based on the conversion formula mentioned in the mark sheet/duly signed certificate of conversion formula provided by the concerned Institute/ University.

## **REFUND POLICY**

Candidates willing to withdraw admission from B.Tech./ M. Tech./ MBA/E-MBA & Ph.D. Program may request for admission cancellation and refund of fees through an application (format available on NIFTEM-K official website). The scanned application is accepted through email from the registered mail id to admission cell. The refund of fees shall be made in due course with a minimum time period of 15 days from the date of receipt of application. Refund shall be made after deduction of due cancellation charges as below:

## **ADMISSION GUIDELINES FOR B.TECH. PROGRAMME**

NIFTEM-K offers two modes of admission for the B.Tech (Food Technology and Management) program, offering 200 seats.

### **1. JoSAA / CSAB 2025: 100 seats**

Candidates must refer to the JoSAA/CSAB 2025 website for its application procedure, guidelines, and updates, if any. NIFTEM-K will not entertain any discrepancies or queries related to admission through this mode.

### **2. Direct Admission (Through NIFTEM-K): 100 seats (JEE- 50, CUET- 30 & NEET-20)**

Under this mode, an individual candidate must complete the registration process by applying through the link mentioned at Page No. 5.

- Out of 100 seats to be filled through Direct Admissions, 50 seats will be filled through JEE-Main, 30 seats will be filled through CUET and 20 seats will be filled through NEET as per the reservation policy of the Govt. of India. Kashmiri Migrants will be allotted 5% supernumerary seats.
- Admission process for seats in respective qualifying exam (JEE/NEET/CUET) will commence as and when the results are declared. Candidates are advised to frequently visit admission portal for latest updates.
- If a candidate wishes to apply under multiple qualifying exams (JEE/NEET/CUET) category, he/she has to submit separate application form for each qualifying exam by completing fresh application on admission portal.

## **OVERALL ELIGIBILITY CRITERIA FOR DIRECT ADMISSIONS**

- Candidate must be Indian nationals, Person of Indian Origin (PIO), or Overseas Citizen of India (OCIs) to apply for NIFTEM-K Direct admission.
- Candidates must have studied at least three subjects among Physics, Chemistry, Mathematics, and Biology during their Class XII (or equivalent) examination.

- Candidate should have a valid JEE Main/NEET/CUET score for the year 2025
- Minimum Eligibility Criteria in Qualifying Exams:

- For candidates who appeared in the Class XII examination for the first time in 2024 and reappeared in any subject (for whatever reason) in 2025, the better of the two performances will be considered.
- If a board gives aggregate marks considering both Class XI and Class XII, then only Class XII examination marks will be considered.
- If a board awards only letter grades without providing an equivalent percentage of marks on the grade-sheet, the candidate should obtain a certificate from the board specifying the equivalent marks and submit it before the deadline for submission of documents. In case the board does not provide such a certificate, the percentage marks will be assessed as follows: Marks (%) = (CGPA or CPI obtained  $\times$  100) / PS, where, PS= maximum value of the point scale used by the respective board.

- **Note:** (i) Mess charges ₹25,800/- (Rupees Twenty-Five Thousand and Eight Hundred only) advance is payable per semester, which is variable, and has to be paid at the time of joining the Hostel.
- (ii) Hostel room rent is not refundable/waived off even when the student proceeds on internship or study tour or vacations.

## ON-SPOT Counselling

- If seats remain vacant after closing of JoSAA/CSAB 2025 admission process, the remaining seats may be filled through On-SPOT counselling. If seats remain vacant after few rounds of Direct Admissions through NIFTEM-K, the remaining seats may be filled through On-SPOT counselling.
- In On-SPOT counselling, merit list will be prepared only on the basis of 12<sup>th</sup> marks (Physics + Chemistry + Mathematics/Biology + English + one additional subject).
- During the on-spot admission process, JEE/CUET/NEET scores will not be considered when preparing the combined merit list. All candidates will be placed in the same pool, regardless of their scores. These scores will serve only as a qualifying criterion for attending the on-spot counselling as per minimum eligibility requirement for the respective exams (JEE/CUET/NEET).
- Eligibility criteria mentioned at page no. 13 will not be diluted under any circumstances.

## Tuition Fee Waiver

NIFTEM-K offers tuition fee waiver to students whose family income is less than 1 Lakh (complete tuition fee waiver) and for students whose family income is within 1 Lakh to 5 Lakh (2/3rd tuition fee waiver). However, it will be implemented once the student takes admission in the course.

### **Note:**

- i) OBC-NCL certificate should be in the prescribed format: - “Form of certificate to be produced by other backward classes applying for appointment to Posts/Admission to Central Educational Institutes under the Govt of India”- (*The format of respective certificate has been attached at Annexure I*)
- ii) EWS/OBC-NCL/Income certificate should be valid for the financial year 2025-26, i.e. issued on or after 01 April 2025. No correspondence will be entertained to update this during later phase of the admission process- (*The format of respective certificate has been attached at Annexure II*)

## PATTERN OF ENTRANCE TEST

The written test for Non-GATE candidates shall consist of hundred (100) multiple choice questions of one mark each, there shall be negative marking and for each wrong answer 0.25 marks will be deducted. The duration of the test will be one hour and thirty minutes. The test shall consist of two parts.

Part-A shall contain thirty (30) questions to test the Mental Ability, English and General Knowledge which is common for all the candidates. ## MODE OF SELECTION
