

## **B.Tech (FTM) Admission 2025 Counselling Guidelines**

### **I. Direct Admission (Through NIFTEM-K): 100 seats (JEE- 50, CUET- 30 & NEET-20)**

#### **i. First Merit List Publication**

The category-wise first merit list for admission to B.Tech (Food Technology & Management) 1<sup>st</sup> year (2025-26) will be tentatively published on 8th July 2025 on the NIFTEM website.

#### **ii. Fee Payment**

Shortlisted candidates from the first merit list need to pay the full admission fee as mentioned in FEE STRUCTURE on page no. 14 of NIFTEM Admission Brochure - 2025. The online fee payment has to be completed within the specified timeframe (tentatively three working days after publication of merit list) via an online payment link. The online payment link along with specific last date to submit fees will be shared with candidates in merit list via their registered email. Important: Candidates should carefully read the payment gateway instructions before proceeding with the payment.

#### **iii. Failure to Pay Fee within specified last date**

If candidate fails to pay the full admission fee within the given deadline, he/she will lose the right to claim the allotted seat. The seat will then be offered to the next candidate in subsequent merit lists.

#### **iv. Second Merit List Publication**

The second merit list will be tentatively published by 15th July 2025 on the NIFTEM website. Shortlisted candidates must follow the same steps outlined in points (ii) and (iii).

#### **v. Third Merit List (if required)**

If seats remain vacant after second merit list of Direct Admission (Through NIFTEM-K), a third merit list (category-wise) will be released. The counselling schedule, seat allotment, and fee payment details will be notified accordingly.

### **II. ON-SPOT Counselling**

- i. If any seats remain vacant after all the rounds of JoSAA/CSAB 2025 admission process and Direct Admission (Through NIFTEM-K), the category-wise vacant seats will be offered to candidates for ON-SPOT admission counselling.
- ii. The minimum eligibility requirement remains same as per page 13 of NIFTEM Admission Brochure -2025 for ON-SPOT counselling admission process.
- iii. Candidates have to register separately to participate in ON-SPOT admission counselling by separately paying requisite registration fee if not registered earlier.
- iv. In On-SPOT admission counselling, merit list will be prepared only on the basis of 12th marks (Physics + Chemistry + Mathematics/Biology + English + one additional subject). JEE/CUET/NEET scores will not be considered when preparing the combined merit list. All candidates will be placed in the same pool, regardless of their scores. These scores will serve only as a qualifying criterion for attending the on-spot

counselling as per minimum eligibility requirement for the respective exams (JEE/CUET/NEET).

- v. Candidates attending the spot round must bring all necessary documents and pay the fee as per the details in the admission brochure on the same day, if seat is offered to the candidate as per merit list.
