



Instructions for Special Drive for SC, ST and other categories

(B.Tech. Admission Session 2025)

A Special Drive counseling session for admitting the SC and ST category candidates and other reserved categories (if vacant) in B.Tech (Food Technology and Management) program for the Session 2025 against vacant seats, will take place on **August 29, 2025 (Friday)** at the NIFTEM Kundli Campus. Candidates are advised to follow these guidelines to ensure eligibility:

1. Reporting time is **10:00 AM sharp on August 29, 2025**. Candidates should reach at the venue early. No late coming shall be entertained.
2. Candidates must be present physically for the spot-round counseling.
3. The candidates must ensure to qualify the following eligibility criteria along with valid scores to attend the spot counselling session;

S. No.	Category & Minimum Eligibility Criteria	Qualified* 12 th Exam with a minimum of 60% for General/Gen-EWS/OBC-NCL & 55% for SC/ST/PWD candidates. * The calculation will be based on considering five subjects: Physics + Chemistry + Mathematics/Biology + English + any one subject of benefit to the candidate.
1	JEE 2025	CRL Rank Below: 06 lakh for General/Gen-EWS/OBC-NCL & 08 lakh for SC/ST/PWD category, respectively.
2	NEET 2025	AIR Below: 08 lakh for General/Gen-EWS/OBC-NCL & 10 lakh for SC/ST/PWD category, respectively.
3	CUET 2025	Must include Physics and Chemistry, plus any one of the following subjects, i.e., Biology/Mathematics. Minimum eligibility: above 35% for General/Gen-EWS/OBC-NCL and 30% for SC/ST/PWD category, considering either PCB/PCM subjects in CUET

4. Other than the minimum eligibility criteria stated above, a consolidated merit list in the respective categories will be prepared based on class 12th marks considering five subjects: (Physics + Chemistry + Mathematics/Biology + English + any one subject of benefit to the candidate).
5. All candidates should visit our Admission Portal regularly for any updates.
6. On the day of counseling, all candidates must bring one set of photocopy documents along with the original documents/mark sheets for physical verification. (Visit admission portal to see the details of check list items)
7. Candidates should carry a demand draft of Rs. 1,22,100/- (General-EWS/OBC-NCL) or Rs. 70,450/- (SC/ST) as per their category in favor of National Institute of Food Technology Entrepreneurship and Management (NIFTEM), payable at Kundli, Sonapat. Mess Charges of Rs. 25,800/- may be submitted on the same day during spot counseling, if a seat is offered to the candidate.
8. Students are also advised to bring debit/credit cards & online banking/UPI services with sufficient transaction limits to avoid any technical delays or transaction issues during fee submission.
9. NIFTEM-Kundli will not be liable for any delays, which may result either in cancellation of merit or provisional admission.
10. The vacant seats available will be displayed on the website two days prior to special drive.
11. In case of seat cancellation by candidates who are offered admission through the special drive, only the caution money will be refunded.
