- Candidates belonging to the OBC-NCL category must produce a valid OBC-NCL Certificate in the prescribed format, namely, "Form of Certificate to Be Submitted by Other Backward Classes for Appointment to Posts/Admissions to Institutes under Government of India." The certificate must have been issued on or after 01.04.2026 and must be submitted

at the time of physical reporting at the Institute. Failure to produce the required certificate may result in cancellation of admission.

- Candidates belonging to the EWS category must submit a valid EWS Certificate issued on or after 01.04.2026 at the time of physical reporting. Failure to produce the required certificate may result in cancellation of admission.
