- The candidates who have been allotted the seat in the 1<sup>st</sup> round of counseling have to pay full admission fee on or before the last date by clicking on the payment gate way link ([https://niftemevent.niftem.ac.in/admission\\_fees/fees.php](https://niftemevent.niftem.ac.in/admission_fees/fees.php)). Candidates who fail to pay the fees within stipulated time of counseling schedule shall have to forfeit his/her claim for seat.

- Candidates are advised to refer the instructions/seat withdraw details given in web page/e-mail received in this regard before proceeding to online fee payment. Candidates whose names do not appear in the First Counselling Merit List are advised not to pay the admission fee at this stage. Further, rounds of counselling, if conducted, will be based on the availability of vacant seats. Eligible candidates will be considered strictly in the order of merit and will be informed accordingly through the official admission portal/website.
- Candidates belonging to the OBC-NCL category must produce a valid OBC-NCL Certificate in the prescribed format, namely, "Form of Certificate to Be Submitted by Other Backward Classes for Appointment to Posts/Admissions to Institutes under Government of India." The certificate must have been issued on or after 01.04.2026 and must be submitted at the time of physical reporting at the Institute. Failure to produce the required certificate may result in cancellation of admission.
- Candidates belonging to the EWS category must submit a valid EWS Certificate issued on or after 01.04.2026 at the time of physical reporting. Failure to produce the required certificate may result in cancellation of admission.
- NIFTEM will not be responsible for any kind of delay/error occurred while paying the admission fee.
- All efforts have been made to allot the seats as per the order of merit. NIFTEM or any of its staff will not be responsible for any inadvertent error for any information being published. Reporting such discrepancy by mail will be acceptable only when the sender's mail id is matching to that provided in the application form of the provisionally selected candidate.
- Admission offered after fee payment through this merit list is purely provisional and is subject to the verification of all original documents at the time of physical reporting. The admission and allotment of the seat shall be confirmed only after successful verification of the original documents and fulfillment of all prescribed eligibility conditions.
