- As per the valid CUET score, the seat allotment for 1st counselling is given below.
- All efforts have been made to allot seats based on the candidates' subject preferences in the order of merit and admission guidelines. However, NIFTEM-K or any of its staff shall not be held responsible for any inadvertent errors that may have occurred in the published information. In case of any discrepancy, candidates may report the issue via email. Please note that such communication will be entertained only if the sender's email ID matches the one provided in the application form of the provisionally selected candidate.
- Candidates allotted a seat in the **1st Counselling** are required to pay the **full admission fee** through the **NIFTEM admission portal** up to **23rd June 2026** (Link:- https://niftemevent.niftem.ac.in/admission_fees/fees.php). Candidates who fail to pay the fees within stipulated time of counselling schedule shall have to forfeit his/her claim for the seat and such candidates will not be considered for the next counselling rounds.
- Candidates are advised not to pay the admission fee until their name appears in counselling schedule/ fee payment notification on website. **Candidates marked as not allotted seat in 1st counselling are not required to make any payment.**
- **Candidates marked as not allotted seat in 1st counselling may get a seat in subsequent counselling rounds if candidates allotted a seat does not pay the fees within stipulated time. Such candidate shall check our website for the next round counselling merit list.**
- **Those Candidates who have applied through both CUET and GATE have been allotted seat in both of the admission modes in the 1st counselling merit list are required to pay the fees only once, depending on their preferred choice of branch or program. After the fee payment is completed, the seat allotted through the other mode (CUET/GATE) will be automatically cancelled. No further claim on the seat/branch and any requests for changes will be entertained thereafter.**
